Cllr Crossley welcomed all to the meeting and invited Cllr Harmer to speak.

Monies available for highways and byways very complicated.

Not clear yet what the monies for Member's Highways Allocation can be used for. Rules will be defined by end of May but can be used on roads and rights of way.

Re: Horizon priorities, Tilford east bridge works will dictate timing (assumed early July)

- 1) Elstead to Farnham
- 2) Hindhead traffic lights to Tilford Road/Churt Road junction.

Potholes two and a half times the annual average for the time of year. Kier deemed good contractors mending what they can.

4 bids in for Member's Allocation, CCC and WI turned down, monies for capital costs for items not already purchased.

OFSTED to publish report regarding adequacy of Children's Services. SCC agree with findings. New director of Children's Services brought in from Essex. Report likely to get media attention.

18/58.2.1 Parking in village centre

Kai (Churt News) raised issue at Annual Assembly re change to time limit of parking outside shops. I hour limit amended to 2 hour limit. Cllr Harmer has spoken to SCC. There were 4 objections to the 1 hour limit incl. Garden machinery shop, Pipasha and logistics company. There is an exemption for loading/unloading. Gary in Garden Machinery shop needs to apply for resident's permit allowing him to park at the front as he is the only resident with no off street parking. Churt PC put in an objection to the change, now moved back to original 1 hour limit.

18/60.1 -To note and comment on current planning applications:

WA/2018/0165 61 Parkhurst Fields, Churt - letter of objection sent 19 April.

WA/2018/0687 Southdown House, Hale House Lane, Churt - no objections but will require a change of use if owners wish to use part as a coffee shop.

Borrow House Farm update - Planning committee met 9 May at Waverley BC.

Granted retrospective planning on unit 10 to be used as an office.

Refused application re the farmhouse as an increase in size by 200% and likely damage to The Flashes.

Application for 3 dwellings also refused due to SSI damage and isolated nature of the development.

Future of site unclear, developer gone very quiet.

18/61 Website update (DC/Clerk)

Website formally launched at Annual Assembly on 18 April. Cllr Waller will become website liaison. Meeting to be arranged with Vicki Kirk re ongoing webmaster role.

18/62 Churt Heritage - licence update

Cllr Crossley and Clerk met with John Brain and Gillian Devine and the licence agreement will be signed off at their meeting on 25 May.

18/63 Emergency Plan Update (GS)

Cllr Stiff has produced a shortened form of the Emergency Plan, awaiting comment from Cllrs Waller and Crossley. Clerk to send original plan to Cllr Waller for reference.

Essence of the plan is to allow Churt PC to run matters in case of an emergency until other category 1 responders arrive or become involved.

Frensham PC have wardens for each part of their parish.

18/64 Adoption of IT and Media policies to comply with GDPR requirements and adoption of Statement of Internal Control

Cllr Waller proposed adoption. Cllr Stiff felt policies were too cumbersome despite being sanctioned by Came and Co. Cllr Crossley suggested adopting them in their current format as an interim measure whilst Cllr Stiff suggests amendments, Seconded by Cllr Waller, 5 in favour, 2 against. To be fully reviewed at July meeting.
